- LakeWood is providing Pfizer vaccine (boosters, 1st and 2nd doses) usually one day every week. They are offering vaccine shots this coming Thursday starting at 1:00 PM. This is open to ages 12 and up.
- Pfizer age 5 to 11 will be available in November sometime. Vaccine for this age group has been ordered. LakeWood is waiting for guidance on start date and protocols. We may provide a vaccine clinic for this group during Parent/Teacher Conferences on November 11 and 16.
- Moderna boosters are now available. LakeWood will hold a clinic for staff at school this Friday starting at 2:30 PM.

While the County-wide numbers have been on an increasing trend, our school numbers have been somewhat consistent. Wednesday, October 20th was a specially challenging day with 7 staff members either COVID-19 or other medical reasons.
