## Informational

Base Learning Model for 2020-2021- Jeff Nelson presented the most recent 14 day case rate to explain his recommendations for starting the school year. Lyon asked how often this would be revisited in terms of case numbers. Nelson explained that the document is released biweekly at the previous 2 weeks.

Update on staffing recommending hiring 3 paraprofessionals to fill open positions. Teaching Mrs. Kemen will move to the highschool science position. We will hire a long term substitute for 6th grade. We will be looking at hiring an additional 2nd grade teacher to account for social distancing. We are also hiring a part time enrichment coordinator and bus driver. Looking at the possibility of hiring a full time in house substitute teacher.

Boyd Johnson asked about why we went with every other day versus 2 day blocks for the high school hybrid model. Mary Merchant explained that it is to keep more consistent contact with students so they aren't potentially not seeing their teacher from one week to the next. She also added that Friday is indeed a student contact day.

## **New Business**

Motion by Ellis Second by Sonstegard to approve the disposal of obsolete IT equipment as presented. Nelson added that it is a list of computers from an overflow lab. These computers are still working but beyond their years so they will be given to families in need for distance learning. Johnson added good job to the IT department for keeping them going for 10 years or so. Motion passes unanimously.
