# School Board Member Resignation & School Board Election Reminder

- In response to Board Member Lynn Ellis' resignation, I will be working with legal counsel on amending the filing notice date and steps to move forward to ensure that the voters of district 1 have the opportunity to choose their next board member. There will be a re-posting of the notice for the general election for Districts 2 (Johnson), 5 (Lyon), and 3 (Trask) and a special election notice for District 1 (Trask) in this week's Northern Light Region

# Capital Projects Levy and Building Bond Referendum

After conferring with our partners from Ehlers, Widseth, and Donovan Group and taking into consideration our operating budget and facilities improvement needs, I am recommending that the board call for a special election authorizing a \$400,000 Capital Projects Levy and a \$4,000,000 Building Bond

# Line of Credit Renewal with Border Bank

To ensure that the district has sufficient cash on hand to make payments for payroll and expenses we are recommending that the district renew its line of credit with Border Bank. This is a shortterm, safety net to get us through the 2024-2025 school year. Terms and conditions will remain the same. The amount advanced at any time under the Line of Credit will not exceed \$350,000 or ninety-five percent (95%) of the District's average expenditure per month of operating expenditures in the previous fiscal year. Each advance under the Line of Credit will be repaid no later than forty-five (45) days after the day of advancement, but in no event later than June 30, 2025, with taxable interest on the outstanding principal amount at the rate per annum determined on the basis of the Prime Rate as reported in the "Money Rates" column of The Wall Street Journal (currently 8.50% per annum), with a .25% origination fee. The Prime Rate shall change effective as of the date of any change as published in The Wall Street Journal.
